REGULATIONS

of the celebration of the 55th anniversary of the founding of the Harley Davidson

Wrocław club to be held in Zieleniec on July 4-6, 2025

The meeting area for participants includes a parking lot in Zieleniec and a nearby green area designated for a camping site.

Persons participating in the meeting or staying on its premises automatically accept its regulations.

The meeting is attended by persons invited by the HDC Wrocław Club, which is the Organizer of the event. Each participant receives an identification band.

Participants of the meeting who are minors may stay on the premises only under the constant care of their parents or their legal guardians, who take responsibility for them.

The meeting is not a mass event. The Organizer reserves the right to limit the number of participants for logistical reasons, as well as the need to ensure the safety of other participants.

In the event of circumstances limiting the number of participants, the Organizer shall not be liable for any damages to persons arriving at the meeting who were not allowed to participate in the event.

The identification band authorizes the holder to stay on the convention grounds, participate in all events and competitions organized on its grounds. The band must be worn on the hand and presented at the request of authorized persons, i.e. organizers and security services.

The organizer reserves the right to refuse entry to the convention grounds, in cases justified by security reasons.

The organizer and persons indicated by him are authorized in relation to persons staying on the convention grounds, to: check participants' IDs in order to establish their identity, issue commands for order, apprehend them for the purpose of immediate transfer to police officers, enforce the behavior required by law.

Only sober persons may leave the grounds on a motorcycle, upon presentation of the identification band and motorcycle registration certificate to authorized representatives of the organizer.

The parking lot on the convention grounds is divided into zones and a motorcycle parking lot.

The parking lot on the convention grounds is free for participants and is not guarded. The organizers are not responsible for theft or damage to property.

After 10:00 p.m. to 8:00 a.m., it is strictly forbidden to start and drive motorcycles and other motor vehicles on the convention grounds.

It is forbidden to block or obstruct exits and evacuation routes, access roads for emergency services in any way.

It is forbidden to bring narcotics, alcohol, dangerous materials and objects, e.g. baseball bats, metal pipes, telescopic batons, knives, etc., weapons, explosives, pyrotechnic products, fire hazard materials, firearms, to the convention grounds.

Participants are prohibited from lighting fires.

The organizers are not responsible for the behavior of participants on and off the grounds. This means that each participant of the convention is liable under civil and criminal law for their own behavior.

In the event of a violation of the rules of the regulations, a violation of good manners or bringing in prohibited items in violation of the ban, the organizer has the right to remove the participant/person from the convention grounds, and in the event of a suspicion of committing a crime, to hand the suspect over to the Police.

The organizers are not responsible for any losses or damages to the participants of the event and their property, as well as for losses or damages caused directly or indirectly to third parties.

Persons who are visibly intoxicated or under the visible influence of narcotics or narcotic substances with an effect similar to alcohol are prohibited from entering or staying at the convention.

All participants of the convention are obliged to maintain order and cleanliness on the convention grounds.

It is forbidden to destroy any infrastructure and property, as well as to move devices without permission. The participant is liable for any of the above damages.

During the convention, participants may consume alcohol purchased only at catering points located on the event grounds.

Participants of the convention are obliged to place their tents only in places designated by the organizers.

The convention is an event insured under general principles. Individual insurance in the event of injury or other unfortunate event that may happen to participants/persons during the event requires a separate policy purchased individually by the participant/person.

Participants of the event acknowledge that entry to the event area is tantamount to granting consent to free photography, filming or other types of recording of their person in connection with the event and to broadcast, distribute voice and image in connection with any program presenting the event.

The organizer will not be obliged to provide any compensation or damages to the participants of the convention, which for reasons beyond the organizer's control has been canceled or will only take place in part.

Participants accept and acknowledge that they may be exposed to continuous exposure to sound intensity that may cause hearing damage as well as to the area of stroboscopic lights, laser effects and pyrotechnic explosions that may cause visual ailments.
